Baseline Emissions Footprint

Fairview Health Ltd is in the early stages of formal carbon measurement and reporting.

At present, we do **not yet have a fully quantified baseline of Scope 1, Scope 2, and Scope 3 emissions**. Establishing a robust and auditable baseline is a priority action within this plan.

During the initial reporting period, Fairview Health Ltd will focus on identifying material emission sources and implementing proportionate data-collection processes appropriate to our size, sector, and operational complexity.

Until formal measurement is completed, emissions are considered **unquantified**.

Current Carbon Reduction Measures

Despite the absence of formal emissions data, Fairview Health Ltd has already implemented a number of practical carbon-reduction measures appropriate to healthcare and pharmaceutical operations, including:

Operational Efficiency

- Digitisation of prescriptions, records, and workflows to reduce paper usage
- Use of electronic invoicing and document management systems
- Optimisation of warehouse layouts to reduce handling and energy usage

Energy and Buildings

- Use of energy-efficient LED lighting across operational sites
- Preventative maintenance of refrigeration and HVAC systems to reduce energy loss
- Rationalisation of operating hours and equipment usage where clinically safe

Transport and Logistics

- Route planning and consolidation of deliveries to reduce vehicle mileage
- Preference for courier and logistics partners with fuel-efficient fleets
- Increased use of remote meetings to reduce business travel

Procurement and Waste

- Responsible sourcing of pharmaceutical packaging where clinically appropriate
- Segregation of pharmaceutical, clinical, and general waste streams
- Compliance with all regulated waste and medicines disposal requirements

Future Carbon Reduction Initiatives

Over the next 12–36 months, Fairview Health Ltd commits to the following actions:

1. **Establish a formal carbon baseline** covering Scope 1, Scope 2, and relevant Scope 3 emissions
2. **Engage external advisers or tools** to support proportionate carbon measurement and reporting

3. **Set internal carbon-reduction targets** once baseline data is available
 4. **Review energy procurement options**, including greener tariffs where commercially viable
 5. **Work with NHS Trusts and partners** to align with local and national sustainability goals
 6. **Annual review and update** of this Carbon Reduction Plan
